

**RATES OF PAY AND CONDITIONS OF SERVICE OF
ENGINEERING CRAFTSMEN IN HOSPITALS**

1. *Rates of Pay*

Revised rates of pay as follows shall operate with effect from the beginning of the full pay period in which 3rd June, 1957, fell:—

**ENGINEERING CRAFTSMEN: RATES OF PAY AND
CONDITIONS OF SERVICE**

Summary. This memorandum concerns engineering craftsmen in hospitals and (i) increases the national rates of pay; (ii) increases the charges for board and lodging and meals.

1. The Minister has decided to increase the rates of pay and charges for board, lodging, laundry and meals contained in the enclosure to H.M. (56) 52. Details of the revised rates and charges are set out in the enclosure to this memorandum and replace those contained in the enclosure to H.M. (56) 52.

2. An undertaking has been given by the craft Unions concerned to continue to co-operate in joint efforts to promote greater efficiency.

3. Under the direction given in the Appendix to this memorandum, the Minister has directed that Regional Hospital Boards, Hospital Management Committees and Boards of Governors shall observe the provisions of this memorandum and its enclosure.
