Target population

Diabetic eye screening is offered to anyone with diabetes who is 12 years old or over. They are invited for eye screening once a year.

Condition screened for

A range of eye problems can affect people with diabetes. One of these conditions is diabetic retinopathy.

This is a complication of diabetes, which is caused by high blood sugar levels damaging the back of the eye (retina). Diabetic retinopathy can cause blindness if it is left undiagnosed and untreated.

Diabetic eye screening test

The <u>DES</u> test (https://www.nhs.uk/conditions/diabetic-eye-screening/what-happens/) usually lasts about 30 minutes.

There are several parts to the test. They are:

- 1. Reading letters on a chart.
- 2. Having eye drops put into each eye.
- 3. A photo taken of the back of the eyes.

Evidence base

Diabetic eye screening is one of 11 <u>NHS</u> national population screening programmes (https://www.gov.uk/guidance/nhs-population-screening-explained) available in England.

The UK National Screening Committee (https://www.gov.uk/government/groups/uk-national-screeningcommittee-uk-nsc) (UK NSC) makes recommendations (https://legacyscreening.phe.org.uk/screeningrecommendations.php) to ministers in the 4 UK countries on all aspects of population screening. It ensures that screening provides more benefit than harm, at a reasonable cost to the <u>NHS</u>.

Recommendations are based on internationally recognised criteria

Commissioning

All <u>DES</u> screening commissioners must follow the <u>DES</u> service specification (https://www.england.nhs.uk/publication/public-health-national-service-specifications/) and use the supporting documents (https://www.gov.uk/government/collections/diabetic-eye-screening-commission-and-provide) to ensure a fit for purpose programme is set up and meets the required standards.

Quality assurance

The role of the screening quality assurance service (SQAS) (https://www.gov.uk/guidance/nhs-populationscreening-quality-assurance) is to:

- · assess the quality of local screening programmes
- monitor compliance with standards
- · support services with improving quality
- undertake regional level quality assurance visits (https://www.gov.uk/government/publications/nhspopulation-screening-regional-quality-assurance-teams-in-england)
